



Waiver of Liability and Mutual Agreement for Protection from Liability

As an Advocates for Clean & Clear Waterways volunteer, I understand I may freely choose to be involved in activities requiring physical activity, activities in or on the rivers, along local beaches and shorelines, litter clean-up activities, contact with foreign and unidentified substances (including contaminated water and wastewater) and other potential risks of infection, bites, stings, injury, or death. I agree that I will only perform activities that I am competent to perform and feel comfortable doing. I also agree to follow all COVID-19 safety and social distancing protocols required by Advocates for Clean & Clear Waterways and local, state, and federal law. I assume any and all risks, whether known or unknown, associated with performing each activity.

I hereby release Advocates for Clean & Clear Waterways, its officers, contractors, directors, employees, agents, and volunteers from any and all actions, causes of action, claims or any liabilities whatsoever, including negligence, for any harm that befalls me or any boat or equipment in my possession or control that arises out of my activities as an Advocates for Clean & Clear Waterways volunteer. I also agree to indemnify and hold harmless Advocates for Clean & Clear Waterways for any damages or liabilities to third parties that arise out of my activities as an Advocates for Clean & Clear Waterways volunteer. My waiver has no expiration date.

This waiver is given in the interest of permitting Advocates for Clean & Clear Waterways volunteer programs to exist and to serve the community at large, and to enable myself to feel free to participate as an Advocates for Clean & Clear Waterways volunteer without fear of liability.

Minors: If signing as the parent or legal guardian of a minor: I give my permission for my minor child (or children) to participate as an Advocates for Clean & Clear Waterways volunteer, and give the same release as above on behalf of said minor(s).
